I am in my early sixties and live alone. I have worked all my life in both the food industry and clerical. I have raised and educated, on my own, four children. I pay my taxes, vote and abide by the laws of this country. I have been abandoned by the politicians and the OPP.

**Occupation Douglas Creek Estates**

I purchased my home in 1999. I thoroughly researched the Caledonia and surrounding area to see where I wanted to live. This house backed onto a farmer's field slated for future development of high-end, single dwelling homes. Perfect! Real estate prices in the area could only go up. That didn't happen. The Provincial Liberal government has purchased the land in an effort to appease the Natives. The Natives continue their illegal occupation and my property is worth nothing. Every single cent I have is invested in this property. I don't have the benefit or luxury of a pension plan. My taxes, mortgage, utilities and cost of living continue to rise. The Liberal Provincial government pays the utilities for the criminals on Douglas Creek Estates. I am filled with rage. My days and nights are chaotic due to the continued and relentless harassment of the criminals living behind my beautiful home. I am financially wiped out and emotionally drained.

**Highlights Only - Otherwise This Would Be A Book**

February 28, 2006 DCE occupied: Tent set up right behind my house with four or five criminals in it. All day and all night fires burned. The smell of smoke, men talking, walking around, chopping wood prevented me from "Quiet Enjoyment of my Premises". I placed a call to the OPP to complain. They did nothing. In the morning these men would stand out in broad daylight and relieve themselves, being sure to stand so you could see them. Not a problem for me but there are children in the houses beside me.

March 10, 2006 Suspicious vehicles on DCE. Called OPP to say too many too close and I didn't feel safe in my own home. OPP sympathized but did nothing. During the month it rained a lot. The ground got wet and muddy which forced the criminals to move to higher ground. After they were out of sight, I went out and picked up the garbage left behind as the wind would only blow it onto my property. I picked up a plastic bag full of papers, bottles, etc. I found a plastic garbage bag, it was too heavy to lift so I turned it out on the ground **IT WAS**

**FULL OF HUMAN WASTE!! feces.**

Nightly harassment by the criminals continued and I could not sleep.

April 8, 2006 Reported theft of plywood and all other building materials left by various contractors, from the site. On a side note it is quite amazing that the criminals have gone public begging for donations of food, clothing, money and building supplies so they can finish the houses. I called the OPP and reported the on-going theft. They said thank you.

April 20, 2006 OPP botched raid, woke by the noise at 4:00 a.m. Did not go back to bed. The criminals put up barricades, set fires and ATVS and 4X4s raced around. All of the houses, on DCE in various stages of completion, were occupied. A lot of people on site. Many wearing camouflage, masks, carrying flags, baseball bats, clubs of various descriptions. I have been catapulted into a war zone. I was and am terrified.

May 17, 2006 Called OPP regarding 10 to 12 natives taking 2X4's off duplex, also going into smaller house, carrying out plywood and other wood. Over the past 6 months, I have seen all kinds of things going in and coming out of the houses. Interesting to note, again, that they have publicly begged for donations so they can winter at DCE. The OPP did nothing. I continue to be harassed at night and cannot sleep.

May 18, 2006 Reported seeing criminals running a wire for electricity and bring in truck loads of shelving units and other items to make their illegal occupation more comfortable. On both occasions, May 17 & 18, OPP took my name and address, said thank you and did nothing. I continue to be harassed at night and cannot sleep.

May 19, 2006 New crates on site. Witness these crates being lowered into large bunkers that the criminals have dug. Beth Hutchison, a friend, was visiting at the time and was so concerned she wrote the American Embassy and Homeland Security. I continue to be harassed at night and cannot sleep.

ps: Three undercover men from ? US ? came and took photos of above - all was well hidden.

May 22, 2006 Barricades on Argyle Street down for one hour. Criminals got mad, pulled down hydro towers, cut hydro poles, set fires, dug up the road, erected the barricades again, blew up hydro transformer throwing community into blackout which lasted 3 days. Their behaviour was extremely threatening. I got about 2 hours sleep that night. The OPP did nothing.

June 04, 2006 OPP officer taken hostage by criminals, after which an unbelievable frenzy broke out behind my house. Mohawk Warriors Doing War Cries! ATVS and trucks roar around. That night a barn and a car were burnt. A young security guard was forced to flee for his life. I cannot describe how awful and how frightening this night was. I did not sleep at all. I was afraid to close my eyes. I called Mayor Marie Trainer the following morning and told her they are out of control. The OPP did nothing.

June 09, 2006 An elderly couple, visiting from the Town of Simcoe, were attacked and swarmed by about 40 Mohawk Warriors on ATVS. This happened in the Canadian Tire Parking Lot. A TV reporter was robbed and beaten so severely he was hospitalized. 15 OPP stood by their cars, on the same parking lot, watched these attacks and did nothing. Did these OPP officers not have parents and grand parents? How can any human being, no matter what uniform they are wearing, stand by and watch an elderly couple be attacked? A U.S. Border Guard was taken hostage and his vehicle stolen. Attempted murder of an OPP officer. Children at the school were terrorized. School in lock down. Many residents left for the night. Not safe. Some people were told to leave by the OPP. I went to bed around 2 a.m. fully dressed, with my window open so I could hear them coming. I had my bag packed at the foot of my bed ready to run.

ps: This became a common thing to do when there was excessive activity on site. I would sleep fully clothed, window open, bag packed in car and backpack at the foot of the bed.

June 16, 2006 Gun fire reported to OPP. Told them I was terrified and could not sleep. Told them that I feared for my life. They were sympathetic but did nothing.

**Sidebar: We, the residents of Caledonia, now realize that the vast majority of our complaints were not even documented by the OPP. We now know to demand their badge number and ask for File Number.**

July 20, 2006 Criminals put up a snow fence across the back of my property. I do not have a back fence. Reported this to OPP. They came and took a look and did nothing. I told them if they didn't take it down, I would. .

July 21, 2006 Twelve OPP officers stood on my property and watched as I struggled to take down the fence. Not one of those young, healthy, strong officers offered to help me! Not only is The Rule of Law dead in this town, but apparently so is chivalry!

August 16, 2006 Called MELT regarding two nights of activity; cars/ATVS/trucks roaring around site until well after 2:30 a.m. also noted an increase of people on the site. Two nights in a row, no sleep

**Sidebar: The residents of Caledonia now realize that MELT does not use File numbers nor do they inform the OPP of complaints. How convenient. On paper, it appears as if nothing is happening here!**

August 21, 2006 Midnight could hear men talking behind my house, got up and saw 3 cars and at least 5 people standing around. I turned on the light and all went quiet. I stood in the window for a long time; they thought I couldn't see them. However, they were smoking and it was easy to see the red glow of the cigarettes. They finally got tired of me watching out the window and left.

August 22, 2006 Called 911 regrading blowing horns. Lights and cars racing back and forth. This started around 11:30 p.m. and continued until around 1:30 a.m. OPP did nothing. They were continuously beating drums and screaming: "IyIyIyIy IyIyIyIy!" An older criminal behind my house was hollering louder and louder, two older female criminals were with him and were laughing and enjoying these terrorist activities very much. **Would these be the same women, claiming to be Clan Mothers by day and loving the earth and adamantly stressing that it was a peaceful occupation?**

This type of intimidation is customary and happens on a regular basis. One night a pickup truck sat out behind my house with its windows down until 2 a.m. and played recorded Native drums and singing on his car radio for all to hear. I have slept with my windows open at night so I can hear them behind my house and am constantly on alert for any changes that indicate that I should run for my life. I am up several times a night because of ongoing terrorist activities. It is their custom to wait until people go to bed and then start with unmuffled ATVS, gun fire, fire crackers, anything to create a disturbance. High voltage lights shining on houses, into back yards and even into bedroom windows. These are reported to OPP. They do nothing. These have been reported to MELT. They have done nothing. These terrorist activities have been reported on a regular basis to politicians both provincially and federally. Nothing is done.

Throughout the illegal occupation there have been backhoes digging holes large enough to be bunkers. After dark activities of cars and trucks in and out, loading and unloading. Rendezvous are carried out by flashing car lights on and off and so on. Morse code? It is hard to believe this kind of activity in the dead of night and wee hours of the morning can be legal. I have heard backup signals from trucks and bobcat throughout the night. Whatever can you do in the dark with a bobcat? I have told the OPP that if they intended to go onto the site they had better do it in the daylight. There are all kinds of holes and mounds of earth throughout the site. These can only be booby traps.

I have given up on calling the OPP for help. Now I call so there will be a record of activities. They have proven over the past six months that they will do nothing to help. The OPP are not here to serve and protect. There is a two tiered justice system. They are here to collect overtime, free meals and sit on their collective asses. A 100 ft. neutral zone was negotiated behind the houses on Thistlemoor and Braemar Streets. The residents were told the OPP would be patrolling this area, too much like work, I guess. They may patrol it occasionally on nice evenings. On one such night, a warrior came running up to the OPP officers cursing and swearing, screaming all kinds of profanity. The OPP did nothing. Three criminal security guards came along and sent him back to his hole in the ground. Literally!

(This particular individual was dug into a bunker like hole in the ground, at night I would see the smoke from the fire he sat around, in the morning I would see him stand up, walk around, relieve himself and then crawl back into his hole.) When people in our survey have been in danger, the OPP have backed off, stood by and watched or took a ridiculous amount of time to respond and did nothing. Now our survey is being barricaded by the OPP (For what reason? Who does this help? We have never been in danger from our citizens. We are stopped and asked if we live here. Are we visiting someone? What is our business in this neighbourhood. Some residents have asked for a pass so they won't be

stopped. My friend, [REDACTED] was delivering an Avon order and was stopped and asked the above questions. Her reply was that she didn't have a pass but she could probably get a yellow arm band with a Star of David if that would help! The OPP refer to Caledonia as **CASHADONIA!** Nice. Very nice. Glad someone is enjoying themselves.  
 ps: One of the reasons the OPP were finally required to patrol the 100' (which in reality became 33') behind the homes is I called the Mayor and said that I was not a human shield for anyone. Ten to twenty OPP in front of our homes with guns and who knows how many criminals behind our homes with guns. I told her the OPP have guns to protect us, not that we should be used to protect them.

In June, Government, people came to interview residents on Thistlemoor, Braemar and McCrae streets to see how they could help the residents of this area. The simple answer is: Get those terrorists off the site! They left by saying: "we will be back in touch by the end of the week". In July we received a form letter saying they were reviewing the information they had collected. August 31, we are still waiting to hear from them. Sure glad it is not a life and death situation, or is it? Should I be surprised? More government bull shit! Another make work project!

In my opinion, the government people and the OPP are a disgrace. The tax paying residents and the business owners in this town are being sacrificed for hoods, thugs, criminals, drug dealers, and terrorists. Ontarians are also being swindled by an inept government who will forward the cost of this fiasco to the tax payers. Local government people have tried to help but have been trampled on. Local government, the courts and the Rule of Law have become the sacrificial lamb for this Sitting Liberal Government.

### **Observations and Opinions**

MELT Major Events Liaison Team - Another make work project. OPP screw up, MELT comes in and sweet talks the residents. Most of us have been calling the OPP for help only to find out that little to no action is taken on our calls. Along comes MELT to say: "we can take better care of your problems because we have contacts that we can talk to on the criminal side. Great, we call MELT, not OPP when we have a problem or concern. To be fair, they do help....here's the catch....when you call MELT no record of your call is made. Therefore when the Government or media call the OPP for an update of incidents they can honestly say they have had no Incident Reports. What do you know? We're being SMOOZED!!

### **SAFETY CONCERNS:**

Warrior tearing up and down the tracks was hit by a train. EMS called but would not go to help him. They were afraid for their safety. OPP called. They did nothing. It was left to the neighbours to lend assistance to someone who had been terrorizing them.

ATV rolled over. EMS called.

Explosion and fire in unfinished house. Caledonia Fire Department called. They could not respond. They called Six Nations Fire Department who got there 30 minutes later. The Caledonia fire station is a 5 minute drive from the DCE location, could not enter. The illegal occupiers would not allow 6N fire department nor their police force into the house. The fire was put out by a bucket brigade. Several terrorists taken to hospital for smoke inhalation and released. What is in those uncompleted houses that the terrorists don't want their own people to see?

ps: In Ontario the Fire Marshall investigates suspicious fires and in cases where people are hurt there is an investigation. Didn't happen!

On each of the above occasions, emergency vehicles were detained because of barriers at the main entrance of DCE and blockade at street entrances. The train incident EMS had to wait until the terrorists with ATVS could pull away the cement abutments on Braemar Street to allow them to back onto the site.

ATV roll over. EMS had to wait until the main entrance could be cleared injured party brought to EMS by pick up truck.

House fire. Five emergency vehicles attended plus 2 EMS. Two fire trucks crossed the filed off the Sixth Line, other vehicles had to wait for main entrance to be made passable. It was reported that 4 people were injured in this

incident. Entrance off Thistlemoor is blocked, no access or exit. Not only is this a recipe for disaster, it is against the law. Oh, I'm sorry-----there is no law in Caledonia!

## CLOSING:

Shame on every single person of authority whose job it is to protect me. Shame on all of you. My health has been under attack because of the constant stress. I now suffer from high blood pressure and depression. I have never been on these medications before in my life. Now we can add the additional expense of my prescriptions. I have no drug plan. The doctor has suggested sleeping pills so I can get proper rest but I can't take them. I may have to make a run for it and I would need to be wide awake.

If you believe that negotiations are with warm, honest, peaceful people, you should have lived with me for the past six month.

Additions: April 28, 2010

"Note the date this was written". I can't begin to tell you how many events have happened since that time that one could refer to as threatening. One thing is for sure, we are no longer the same people we were, we have been left to deal with the ugliness by ourselves. Everyone of us, within the zone, are suffering from some degree of post dramatic stress syndrome; however it isn't even post as it is still ongoing and could become full blown again at any time. We are tired, we have been living in a war zone for over 4 years, while our police and political leaders hide behind political correctness. The radicals, thieves, thugs and terrorist hide behind the race card. No one can speak out against them without fear of being labelled a racist or being set up for intimidation by them or God forbid the OPP. My phone has been tapped, off and on, over the past 4 years. Why? I am too old to do anyone any harm. We watch as the OPP and the court system target people who speak out against the criminals. I have told the Ontario Government over and over in the past that the 6N reserve is controlled by organized crime, even the 6N people are saying the same thing. I went so far as to say to the OPP ( John Percerloff ) that someone at the top is making a lot of money off of this, believe me that did not go over well. Illegal smoke shops, out of the 24 cigarette factories on the reserve, only two are legal, however at the time of the original writing they were not being inspected because the government were afraid to send their inspectors there. Government people have attend the DCE on Government business only to be called off the site for fear of their safety. What does that tell you? Have they done anything to ensure the safety of the residents in the zone? NO. I lost all faith in 911 dispatchers who ran you through a bunch of questions before they would dispatch help. Questions like: vehicles behind the house- what kind of car is it? A. I don't know its dark.: Q. Can you identify the person? A. No it is dark: Gunfire - Q. what kind of gun is it? A. Don't know its dark, what do I know about guns. On and On.

May 17, 2007?8?

I also witnessed the AK47 event which I am sure everyone knows about by know. I saw the man with the gun, heard him threaten to kill, not just once but at least twice and reported the same to the OPP. I did not use the 911 or any of the numbers given to me by the OPP and MELT; I ran to the cruiser parked by the school yard (where they maintained a lookout during school hours for fear of problems with the children) yelling at the top of my lungs telling them he was going to kill someone. They wanted to know what kind of gun he had and I told them it was a BIG gun. This time the criminal was apprehended after he shot up a smoke shop and wounded a teenager. Can you imagine if this guy had decided to shoot up the school?
